4. METHOD OF PERSONAL DATA COLLECTION

Your personal data may be collected verbally, in writing or through electronic means; during your participation through the invitation sent to you for fairs organized by our company, during our advertising/marketing activities (sending commercial electronic messages, sharing photo-video recordings), from all information and documents provided by you through automatic/semi-automatic or non-automatic means provided that it is part of any data recording system.

5. METHOD OF PERSONAL DATA COLLECTION

- a. Your personal data specified in the categories above is collected through cookies, information systems and electronic devices allocated to you (computers and phones), other information system tools (email tracking, internet and network access logging, etc.).
 - b. Your personal data may be collected verbally, in writing or electronically through our websites or mobile applications when you apply for membership, become a member of the Gaboras platform, benefit from services offered through the platform, participate in or apply for Digital Real Estate Literacy Training, benefit from or apply for Local Network service, contact us to receive service from us or provide service to us, benefit from or apply for our demo services, submit your information, support, pre-application requests to us by using information/pre-application/contact and other forms on our website or through other channels, benefit from or apply for our paid or free real estate appraisal reports, participate in our trainings, share announcements etc. on our website, participate in our marketing/advertising activities, from all information and documents provided by you or obtained through official institutions and organizations and other third parties, depending on the nature of the Gaboras service you use or apply for and the channel through which you contact us, through automatic/semi-automatic or non-automatic means provided that it is part of any data recording system.

c. If you inform/transmit the personal data of third parties (real estate owner/tenant, persons listed in the land registry) to our company as Data Controller and share this data on our website, pursuant to Article 6 of the Communiqué on the Procedures and Principles to be Applied in Fulfilling the Information Obligation, these persons must be informed separately by you as the data controller and by our company as the data controller. If you share the contact information of these third parties with us, these persons will be reached via email and other channels and will be informed about the processing of their personal data. In cases where you mislead us that the personal data you share does not belong to you, you have not shared the contact information of third parties, the contact information you shared is incorrect, you have not informed these persons that you will share their data with the public on our website and that it will be processed and shared by us, including cases where personal data is obtained unlawfully or shared with our company as the data controller, all obligations and responsibilities will belong to you

6. TRANSFER OF PERSONAL DATA

a. Your personal data may be transferred to and processed domestically or abroad, in compliance with Articles 8 and 9 of KVKK and other relevant legislation, limited to the realization and fulfillment of the above purposes, to Public Institutions or Organizations (Tax Office/Ministry of Treasury and Finance, etc.), our company departments as data controller, our business partners, solution partners, shareholders, suppliers, customers, potential customers, domestic or foreign group companies and affiliates with which we have direct or indirect relations, our lawyers, financial advisors, domestic/foreign organizations and other third parties who are jointly

responsible with us in taking data security measures such as preserving all kinds of your personal data, preventing unauthorized access and preventing unlawful processing, with whom we receive services and cooperate to carry out our activities.

7. YOUR RIGHTS

- a. Within the scope of Article 11 of Law No. 6698 on the Protection of Personal Data, which regulates the rights of the data subject, we inform you that you have the right to learn whether your personal data is processed; if processed, to request information about it; to learn the purpose of processing your data and whether it is used in accordance with its purpose; to know the third parties to whom your data is transferred domestically or abroad; to request correction if your data has been processed incompletely or incorrectly; to request deletion or destruction of data if the reasons requiring processing have ceased to exist, even though it has been processed in accordance with the Law and other relevant legal provisions; to request that the correction, deletion or destruction of your data be notified to third parties to whom the data has been transferred; to object if a result emerges against you as a result of analyzing data exclusively through automated systems; to request compensation for damages if you suffer damage due to unlawful processing of your data.
- b. As a Data Subject, you may submit your requests by filling out the "Data Subject Application Form" which you can access from the website address above, to the postal address above in writing via notary public or registered mail with return receipt in accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller, to our KEP address above using registered electronic mail (KEP), secure electronic signature, mobile signature, or using your email address that you previously notified us and is registered in our system, or to our email address dedicated to KVKK communication.
